In what circumstances can subprocessors access Customer Data, and how do they use it?

21Vianet may hire other subcontractors to provide limited services on its behalf (as listed in the above Subprocessor List). Where the subcontractors require access to Customer Data (including Personal Data contained therein) to perform work that may, they are considered a subprocessor.

Subprocessors may only access and process Customer Data for the purpose of providing the services that 21Vianet retained them to provide. They are prohibited

from using Customer Data for any other purpose, and they are required to maintain the confidentiality of your information. All subprocessors must follow our privacy standards or privacy standards equivalent to our own. Subprocessors are also required to meet EU General Data Protection Regulation requirements, including those related to employing appropriate technical and organizational measures to protect personal data.

Where is my Customer Data stored when subprocessor is processing my Customer Data?

Customer Data will be stored only in data centers located in mainland China. Only for the purpose of providing the limited services as set forth in the above list, 21Vianet may authorize subprocessors to access Customer Data. We carefully monitor such access and terminate the access when the related service is completed.

子处理方在什么情况下可以访问客户数据,以及他们将如何使用客户数据?"
